AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO EXECUTE A CONTRACT WITH GUY G. LATESSA INSURANCE AGENCY, INC. AND ARTHUR J. GALLAGHER RISK MANAGEMENT SERVICES, INC. FOR THE PURCHASE OF A COMPLETE PACKAGE OF VARIOUS INSURANCES ON BEHALF OF THE CITY OF HUBBARD, OHIO FOR POLICY YEARS 2019-2021.

WHEREAS, the City of Hubbard, Ohio has publicly bid various types of insurances both liability and casualty for the City; and

WHEREAS, The City of Hubbard, Ohio is in need of a comprehensive policy of various types of insurance as defined in the bid specifications; and

WHEREAS, State of Ohio law deems it prudent to publicly advertise and award contracts based upon bidding procedures; and

WHEREAS, after receiving and publicly opening bids for said insurance coverages the Guy G. Latessa Insurance Agency and Arthur Gallagher Risk Management has been determined to be the lowest and best-qualified bidder for said insurance.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control is hereby authorized and directed to enter into a contract with the Guy G. Latessa Insurance Agency, Inc. and Arthur J. Gallagher Risk Management Services, Inc., with Guy G. Latessa serving as agent, for various types of insurances as specified in the bidding specifications. Said contract shall be for calendar year 2019, with automatic renewals for 2020 and 2021. The total term of the contract award is three (3) policy years.

SECTION 2: The City Auditor is hereby authorized to pay the contract costs from the appropriate insurance line item appropriations within the City budget annually.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
