AN ORDINANCE

CREATING THE POSITION OF SERVICE SUPERINTENDENT FOR THE CITY OF HUBBARD.

WHEREAS, the City of Hubbard operates electric, water/sewer, street and utility billing departments; and

WHEREAS, the City of Hubbard is in need of a full time supervisor to coordinate services provided by these departments.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: There is forthwith created a position of Service Superintendent for the City of Hubbard.

SECTION 2: The Service Superintendent shall be selected from the qualified candidates by the Service Director.

SECTION 3: The Service Superintendent position will be a full time exempt, non-bargaining unit salary position.

SECTION 4: The salary of the Service Superintendent shall be \$65,000 per year.

SECTION 5: The Service Superintendent shall be granted all benefits, insurance, PERS, and like benefits of the collective bargaining unit members of which he is supervisor.

SECTION 6: The City Auditor shall pay the salary and any other compensation 30% from Light Fund 705, Line Item 705-5010-52110; 25% from Water Revenue 715, Line Item 715-5020-53110; 25% from Sewer Fund 730, Line Item 730-5030-52110; and 20% from Street Construction 205, Line Item 205-6010-52110.

SECTION 7: The job description for the position of Service Superintendent is attached hereto and incorporated as if fully rewritten herein.

SECTION 8: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 9: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law
