AN ORDINANCE

AUTHORIZING THE SAFETY DIRECTOR AND MAYOR TO ENTER INTO A THREE YEAR CONTRACT ON BEHALF OF THE CITY OF HUBBARD, OHIO, WITH THE SERGEANT UNIT OF THE FRATERNAL ORDER OF POLICE (FOP) LODGE 132, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio, administration has conducted negotiations with FOP Lodge 132; and

WHEREAS, such negotiations have provided a tentative agreement between the parties; and

WHEREAS, City Council and the administration have reviewed such proposal and do desire to ratify, adopt, and execute such agreement.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Safety Director and Mayor are hereby authorized and directed to enter into a three-year agreement with FOP Lodge 132-Sergeant Unit on behalf of the City of Hubbard, Ohio, a copy of which agreement/contract is attached hereto and made part hereof as though fully rewritten here by reference, marked as "Exhibit A".

SECTION 2: This Ordinance is hereby declared to be an emergency Ordinance necessary for the health, safety, and welfare of the City of Hubbard, Ohio by virtue of the fact that current union employee contracts expired December 31, 2017, and therefore time is of the essence, and as such, this Ordinance shall take effect immediately upon its passage and approval by the Mayor, or in the alternative, from and after the earliest time permitted by law.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
