A RESOLUTION

AUTHORIZING THE BOARD OF CONTROL TO ADVERTISE FOR BIDS PER THE COMPREHENSIVE IMPROVEMENT PLAN FOR THE CITY OF HUBBARD WASTE WATER TREATMENT PLANT, PHASE II, GRIT BUILDING UPGRADES AND AERATION SYSTEM IMPROVEMENTS.

WHEREAS, the City of Hubbard, Ohio needs to operate its WWTP in an efficient and lawful manner, and

WHEREAS, the WWTP requires upgrading to remain in compliance with current and future regulations, and

WHEREAS, the City of Hubbard, Ohio has adopted a comprehensive plan to upgrade its WWTP.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control is hereby authorized and directed to advertise for bids for Phase II of the comprehensive plan.

SECTION 2: All prior Resolutions and Ordinances or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
