A RESOLUTION

AUTHORIZING MS CONSULTANTS ON BEHALF OF THE CITY OF HUBBARD TO FILE THE NATUREWORKS APPLICATION WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES.

WHEREAS, the City of Hubbard desires financial assistance under the NatureWorks Grant Program

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The City of Hubbard approves filing this application for financial assistance.

SECTION 2: MS Consultants is hereby authorized and directed to execute and file an application with the Ohio Department of Natural Resources and to provide all information and documentation required to become eligible for possible funding assistance.

SECTION 3. The City of Hubbard does agree to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms of the NatureWorks Grant Program.

SECTION 4: All prior Ordinances and Resolutions or parts thereof in conflict with this Resolution are hereby repealed.
