A RESOLUTION

AUTHORIZING THE BOARD OF CONTROL TO ADVERTISE FOR BIDS FOR REPLACING 350 FEET OF SANITARY DRAINAGE PIPE LOCATED ON ERIE STREET BETWEEN JONES STREET AND TAYLOR STREET.

WHEREAS, the City of Hubbard, Ohio, seeks to improve and maintain the condition of sanitary drainage lines within the city to improve sanitary pipe quality and to repair breaks; and,

WHEREAS, the cost of said program would exceed an amount whereby the City of Hubbard, Ohio, would be required to advertise for bids for such a contract.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control is hereby authorized and directed to advertise for bids for Replacing 350 Feet of Sanitary Drainage Pipe Located on Erie Street Between Jones Street and Taylor Street.

SECTION 2: All prior Ordinances and Resolutions or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
