A RESOLUTION

A RESOLUTION BY THE COUNCIL OF HUBBARD, OHIO IN SUPPORT OF RENAMING MYRON STREET BRIDGE ON MYRON STREET, TO BE RENAMED "HUBBARD VETERANS BRIDGE".

WHEREAS, various bridges throughout Trumbull County have been renamed to honor the military men and women who selflessly served our country; and,

WHEREAS, the Council of the City of Hubbard wishes to formerly support the renaming of Myron Street Bridge located on Myron Street to honor Hubbard veterans of wars .

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: That Council and the Administration of the City of Hubbard, Ohio hereby support the renaming of Myron Street Bridge on Myron Street, Hubbard, Ohio, to be renamed "Hubbard Veterans Bridge".

SECTION 2: The Clerk of Council is hereby directed to forward certified copies of this Resolution to the Trumbull County Commissioners and the Trumbull County Engineer.

SECTION 3: All prior Ordinances and Resolutions or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
