AN ORDINANCE

ADJUSTING THE COMPENSATION OF THE WARD AND COUNCIL AT LARGE MEMBERS OF HUBBARD CITY COUNCIL, HUBBARD, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Hubbard, Ohio wishes to compensate the Ward and Council at Large Members of Hubbard City Council, of the City of Hubbard, Ohio at a rate commensurate with the duties and responsibilities of the position and office.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The salary of the Ward and Council at Large Members of Hubbard City Council of the City of Hubbard, Ohio, commencing with the term of office beginning January 1, 2022, shall be \$6,600.00 annually:

SECTION 2: The Ward and Council at Large Members of Hubbard City Council of the City of Hubbard, Ohio shall be entitled to and granted participation in the Ohio Public Employees Retirement System and life insurance and such other benefits as from time to time may be awarded unless otherwise excluded by valid resolution or ordinance of this Council.

SECTION 3: The City Auditor is hereby authorized and directed to appropriate the necessary funds from the proper City line items and funds in accordance with the relevant percentages to effectuate the foregoing provisions.

SECTION 4: This Ordinance is hereby declared to be an emergency Ordinance for the health, safety, and welfare of the City of Hubbard byvirtue of the fact that compensation for elected officials cannot be raised during a term of office, and therefore time is of the essence, and as such this Ordinance shall take effect upon its passage and approval by the Mayor, or in the alternative, from and after the earliest time permitted by law.

SECTION 5: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 6: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
