AN ORDINANCE

AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT OR CONTRACTS WITH THE AFFECTED PROPERTY OWNERS FOR THE TRU SR 82-13.89 PART 2; PID NO. 101248 PROJECT KNOWN AS THE "MYRON STREET SIDEWALK PROJECT" FOR THE PURPOSES OF RIGHT-OF-WAY ACQUISITION.

WHEREAS, the City of Hubbard desires to construct a new sidewalk on Myron Street from approximately Stewart Street to North Main Street; and

WHEREAS, the City of Hubbard must obtain right-of-way for the purposes of constructing the new sidewalk; and

WHEREAS, the City of Hubbard has established fair market value for the property to be acquired in accordance with the Ohio Department of Transportation requirements;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Ohio:

SECTION 1: That the Mayor, as Chief Executive Officer, is hereby authorized and directed to enter into a contract, or contracts for a total amount not to exceed Ten Thousand Dollars (\$10,000.00) with the affected property owners. In addition, once the contracts (easements) have been received, the Mayor is authorized to process a warrant as necessary for the acquisition of the property.

SECTION 2: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
