ORDINANCE NO. 2-22

PASSED FEBRUARY 7 20 22

AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT WITH SEVEN BROTHERS PAINTING, CONTINGENT UPON RECEIVING OHIO WATER DEVELOPMENT AUTHORITY FUNDING, FOR THE CHRISTIAN AVENUE TANK REHABILITATION PROJECT AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio deems it necessary to repaint the existing Christian Avenue Tank in accordance with the requirements of the Ohio EPA; and

WHEREAS, the Christian Avenue Tank Rehabilitation Project was advertised and bid pursuant to law; and

WHEREAS, the City of Hubbard is in the process of obtaining a loan through the Ohio Water Development Authority to fund the improvements.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: That the Board of Control of the City of Hubbard is authorized and directed to enter into an agreement and contract with Seven Brothers Painting, accepting the bid in the amount of \$415,980.00 for the completion of the Christian Avenue Tank Rehabilitation Project in accordance with the specifications as prepared by its consultants and the City Engineer's office.

SECTION 2: Acceptance of the bid and execution of the agreement and contract with Seven Brothers Painting is contingent upon receiving satisfactory funding through the Ohio Water Development Authority.

SECTION 3: This Ordinance is hereby declared to be an emergency Ordinance for the health, safety, and welfare of the City of Hubbard and as such shall take effect upon its passage and approval by the Mayor, or in the alternative, from the earliest time permitted by law.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
