AN ORDINANCE

ADJUSTING WATER RATES CHARGED TO CONSUMERS INSIDE OF THE CORPORATION LIMITS OF THE CITY OF HUBBARD, OHIO, EFFECTIVE JANUARY 1, 2023.

WHEREAS, the City Council of the City of Hubbard, Ohio deems it immediately necessary to modify the rates charged for water due to the increased costs of purchasing said water and maintaining the City of Hubbard, Ohio, water system; and

WHEREAS, City Council finds that the rates or charges as hereinafter set forth are fair and equitable.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: Commencing January 1, 2023 the price to be charged for water to consumers inside the corporation limits of the City of Hubbard, Ohio, shall be as follows:

1. \$17.39 per user per month;
2. \$3.46 per one hundred (100) cubic feet per month

SECTION 2: Commencing January 1, 2024 the price to be charged for water to consumers inside the corporation limits of the City of Hubbard, Ohio, shall be as follows:

3. \$18.78 per user per month;
4. \$3.74 per one hundred (100) cubic feet per month

SECTION 3: Commencing January 1, 2025 the price to be charged for water to consumers inside the corporation limits of the City of Hubbard, Ohio, shall be as follows:

5. \$20.28 per user per month;
6. \$4.04 per one hundred (100) cubic feet per month

SECTION 4: Commencing January 1, 2026 the price to be charged for water to consumers inside the corporation limits of the City of Hubbard, Ohio, shall be as follows:

7. \$21.90 per user per month;
8. \$4.36 per one hundred (100) cubic feet per month

SECTION 5: Commencing January 1, 2027 the price to be charged for water to consumers inside the corporation limits of the City of Hubbard, Ohio, shall be as follows:

9. \$23.65 per user per month;
10. \$4.71 per one hundred (100) cubic feet per month

SECTION 6: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 7: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.


