ORDINANCE NO. 17-22

PASSED July 18, 2022

AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT WITH KARVO COMPANIES FOR THE 2022 STREET RESURFACING PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio, deems it necessary to repair and/or resurface certain city streets, as contained in the 2022 street resurfacing program currently on file with the City of Hubbard City Engineer's Office, and

WHEREAS, streets to be resurfaced were advertised or bid pursuant to law, and

WHEREAS, further delays with the pavement replacement program will most likely cause irreparable damage to the streets and substantially increase the cost of repairing said streets.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Trumbull County, State of Ohio:

SECTION 1: That the Board of Control of the City of Hubbard, Ohio, be and hereby is authorized to enter into an agreement and contract with Karvo Companies for an amount not to exceed \$418,729.45 for the completion of the 2022 Street Resurfacing Program, in accordance with identified streets as described in the bid specifications as prepared by its consultants, inc., and the City Engineer's Office.

SECTION 2: The City Auditor is hereby authorized and directed to encumber all necessary funds in the appropriate funds #100 – General; #205 Street; and #405 Capital Improvement.

SECTION 3: This Ordinance is hereby declared to be an emergency measure and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard, Ohio.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
