A RESOLUTION

AUTHORIZING THE BOARD OF CONTROL TO ADVERTISE FOR BIDS FOR THE CITY OF HUBBARD 2022 LEAD SERVICE LINE REPLACEMENT PROJECT.

WHEREAS, the City of Hubbard, Ohio, desires to replace existing lead service lines within the water distribution infrastructure, and

WHEREAS, the 2022 Lead Service Line Replacement project will replace existing lead service lines identified by the Water Department of the City of Hubbard, Ohio and,

WHEREAS, the City of Hubbard, Ohio has obtained H2O Ohio grant funding and Ohio EPA Water Supply Revolving Loan Account funding for this project, and

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control is hereby authorized and directed to advertise for bids for the 2022 Lead Service Line Replacement Project.

SECTION 2: All prior Ordinances and Resolutions or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
